## Appendix I

### CONDITIONS COVERING THE FACILITY

#### **The Following Conditions Will Be Applied To The “Telephoned Betting” Account Facility:**

1. Apply amounts only to the races specified by the account owner.
2. Effect deposits and payments only from the account owner specified on the form.
3. Initiate a payment only upon the “phone-in” instructions of the account owner.
4. Withdraw this facility at any time in its absolute discretion.
5. One day’s notice must be given for queries on any betting transaction as well as requests for statements.
6. All telephone calls will be recorded.
7. The Arima Race Club will not be assigning accounts to legal residents of the United States of America, nor will it be reselling to any entity which accepts wagers or open accounts to legal residents of the United States of America.
8. All information provided by the account owner must be true and accurate.
9. The account owner will be placing wagers for personal and private use only and will not make any information, material or services available from the Arima Race Club to any person.
10. Any wagers placed by a person other than the account owner is strictly prohibited.
11. The account owner agrees to give the right for the Club to conduct a criminal background check.
12. Transfer of funds between accounts is strictly prohibited.

#### **Rules Applicable To Telephone Betting Account Holder (What is Telephone Betting About?)**

Your account will have its own account number and password that is provided by you. We have two systems available, cash accounts or credit card accounts. Deposits can be made in person at the track or at one of our Off Track Betting (OTB) Shops. You may wager up to the balance in your account and winning tickets will be credited immediately so you may wager against your winnings.

If you are 18 years or older and are a national of Trinidad and Tobago you are eligible to open an account with us. Applications must be delivered in person by the Account Holder mentioned above in Section A. Deposits of cash, bank drafts, certified cheques and money orders will be credited immediately to your account. Deposits made by cheque **will not** be credited until six (6) working days following receipt of the cheque. You should be advised that all bets are subject to a 10% government tax.

Bets can be made by telephone each racing day as early as 30 minutes prior to post time of the first race. You are urged to place bets as early as possible as we cannot be held responsible for not registering your bets in time for the race. You should be advised that it takes longer to process a bet by telephone and there is a greater possibility of being ‘shut-out’.

How are bets placed? When you place a bet, you will be asked for your account name. The operator will ask you for your password. If correctly provided, you will be given your account balance and you will be able to make wagers up to that amount. When placing a wager, please specify the **Race Track** and the **Race Number**. **The operator will repeat your wager and wait for your acknowledgement that it is correct.** If a discrepancy arises as to any portion of the accepted wager, the bet that was repeated by the operator and acknowledged by the caller will be considered the actual bet.

#### **The Customer Is Required To:**

1. Complete the authorization form, Section C, including and especially the signature and appropriate identification number(s). The completed authorization form, Section C, must be lodged with the Arima Race Club
2. Include all credit card and account numbers with expiry dates to be used for telephoned betting.
3. Dial the appropriate telephone number 800-4BET(4238), quote the correct credit card or account numbers and password consistent with the authorization form, Section C, and indicate the exact amount of the wager and the race to which the amount should be applied.
4. Advise the Arima Race Club on any revision regarding the owner’s account changes (credit card numbers, or account numbers). Changes must be reflected on a revised authorization form, Section C, signed by the customer.
5. Satisfy the service representative that the owner’s account information is consistent with those given on the authorization form, Section C, when phoning-in betting instructions.

## Appendix II

### TERMS AND CONDITIONS OF SERVICE

#### 1. GENERAL TERMS AND CONDITIONS

- (a) The Customer named in the official receipt (the "Customer") understands that he/she is responsible for all users of the Arima Race Club's services/signal (the "Service") at his/her premises, identified in the receipt, (the "Premises") and is liable to Arima Race Club for any damage or loss to its Network or Service/Signal resulting from any acts and/or omissions of such users. Customer acknowledges and agrees that he/she is solely responsible and liable to Arima Race Club for any and all breaches of the Terms and Conditions of Service/Signal (the "Agreement") whether such breach is the result of use of the service/signal by the Customer or by any other user at his/her premises. Customer agrees to indemnify and hold harmless against all and any claims and expenses (including reasonable attorney fees) arising out of the unauthorized use of the Service/Signal by any other user or person at the premises or elsewhere.
- (b) Customer agrees not to authorize, consent to or cause (directly or indirectly) the distribution and transmission of the Service/Signal at any place other than the premises and understands that to do so may result in the immediate termination of the Service/Signal and legal proceedings being brought against him/her.
- (c) Customer acknowledges and warrants that he/she owns leases and occupies the Premises and is authorized thereby to connect the Service/Signal to the premises.
- (d) Customer of the Racing Channel Service/Signal will have to subscribe to an authorized telephone betting account with the Arima Race Club and must be placing wagers or their service will be de-activated.
- (e) Continued use of the Service/Signal constitutes acceptance of this Agreement and any future versions. If you are dissatisfied with the Service/Signal of any related terms, condition, rules, policies, guidelines or practices, your sole and exclusive remedy is to discontinue using the Service/Signal and, if you are a Customer, to terminate your account.

#### 2. SIGNAL/SERVICE

- (a) **Ownership of the Signal:** Customer acknowledges that the signal shall remain the property of the Arima Race Club or its designee and warrants and undertakes not to sell, transfer, lease, encumber, assign all or any part of the Service/Signal to any third party or otherwise.
- (b) No Customer is authorized to use this Service/Signal for the purpose of conducting private betting under the Gambling and Betting Act; Chapter 11:19 Act 22 of 1963 and Subsequent amendments. It is an offence by law to engage in this practice.
- (c) **Termination of Service/Signal:** Customer shall give at least seven (7) days notice to the Arima Race Club of their intension to discontinue Service/Signal

#### 3. INTERRUPTION OF SERVICE/SIGNAL

The Service/Signal is provided by the Arima Race Club "As is" without warranty of any kind.

The Arima Race Club does not guarantee uninterrupted use of the Service/Signal. The Arima Race Club shall not be liable to compensate any customer for any interruption or break in the transmission of the Service/Signal, breakdown or failure of the network or any inability by FLOW to repair or replace any FLOW equipment. Arima Race Club shall use its best efforts to maintain and repair the service/signal promptly but assumes no responsibility for the following:

- Commercial power failures.
- Cessation of transmission by radio or television broadcasting stations or television satellite programmes.
- Statutory regulations, which may restrict, alter or otherwise eliminate certain kinds of programming.
- The failure or cessations, in whole or part, of signal delivery systems and/or other services provided by common carriers or utilities to FLOW.
- Battery replacement in remote controls.
- Work stoppage due to labour dispute, strikes and civil unrest.
- Acts of God, including floods, storms, hurricanes, wind, lightning accidents, earthquakes, and adverse atmospheric conditions.
- Sabotage, theft or intentional or malicious damage to the FLOW Network or Equipment.
- Negligent acts of the Customer or anyone authorized thereby to use the Service/Signal.

- Any other interruption in the Service/Signal not caused by an intentional or negligent act of Arima Race Club which is beyond the control of Arima Race Club.

4. **NO TRANSFER OF SERVICE/SIGNAL**

In the event the Customer requests a transfer of the Service/Signal, and continues to reside within FLOW's service/signal area, this Agreement shall remain in force and effect.

5. **AMENDMENT**

Arima Race Club may, at any time and at its sole discretion, change, modify, add or remove portions of this Agreement. The Customer's continued use of the Service/Signal following notice of any change shall be deemed to be Customer's acceptance of any such modification. If the Customer does not agree to any such modification, he must immediately stop using the Service/Signal and notify Arima Race Club that he wishes to terminate this Agreement in accordance with Section 2 c above.

6. **INDEMNIFICATION**

The Customer agrees to indemnify the Arima Race Club from and against all loss, damage, costs and expenses suffered or incurred by Arima Race Club from a breach of this Agreement by the Customer, their servants, agents or any other person who was authorized by the Customer to use the Service/Signal at the time of the breach.

7. **ENTIRE AGREEMENT**

The Customer agrees to the Terms and Conditions set forth herein and acknowledges that these terms and conditions of Service/Signal supersede any previous terms, conditions or agreements between Arima Race Club and the Customer.
